SHELTER: ODS OPERATES AN EMERGENCY SHELTER FOR 42 HOMELESS MEN, 20 WOMEN AND A FACILITY FOR FAMILIES WITH CHILDREN WITH A CAPACITY OF 35. THE SHELTER CASE MANAGEMENT SERVICES TEAM PROVIDES COMPREHENSIVE SERVICES INCLUDING COUNSELING, CRISIS INTERVENTION, GOAL PLANNING, REFERRALS TO ADDITIONAL COMMUNITY SUPPORT SERVICES, FINANCIAL MANAGEMENT, JOB SEARCH AND SKILL TRAINING, TRANSITION TO HOUSING SUPPORT AND ACCESS TO HOT MEALS, SHELTER, SHOWER, TOILETRIES, CLOTHING LAUNDRY FACILITIES AND COMPUTERS/PHONES. CHILDREN ALSO RECEIVE PRE-SCHOOL EDUCATION AND AFTER SCHOOL/HOMEWORK ASSISTANCE, SCHOOL SUPPLIES, SNACKS AND RECREATION ACTIVITIES.

FOOD: THE MANNA HOUSE FOOD PROGRAM, A HOT MEAL PROGRAM PROVIDES BREAKFAST, LUNCH, AND DINNER SEVEN DAYS PER WEEK TO THOSE IN NEED. THE SHELTER ALSO PROVIDES A FOOD PANTRY, WHERE BOXED FOOD IS DISTRIBUTED DAILY. LAST YEAR A TOTAL OF 133,078 HOT MEALS WERE SERVED OR AN AVERAGE OF 365 MEALS A DAY. IN ADDITION THE SHELTER PANTRY PROVIDED 266,520 MEALS TO MORE THAN 1000 INDIVIDUALS LIVING IN POVERTY.
