SHELTER: ODS OPERATES AN EMERGENCY SHELTER FOR 14 SINGLE WOMEN, 42 SINGLE MEN - PLUS 9 OVERFLOW BEDS, AND 28-35 MEMBERS OF FAMILIES INCLUDING 12-25 CHILDREN. THE SHELTER CASE MANAGEMENT SERVICES TEAM PROVIDES COMPREHENSIVE SERVICES INCLUDING COUNSELING, CRISIS INTERVENTION, GOAL PLANNING, REFERRALS TO ADDITIONAL COMMUNITY SUPPORT SERVICES, FINANCIAL MANAGEMENT, JOB SEARCH AND SKILL TRAINING, TRANSITION TO HOUSING SUPPORT AND ACCESS TO HOT MEALS, SHELTER, SHOWER, TOILETRIES, CLOTHING LAUNDRY FACILITIES AND COMPUTERS/PHONES. CHILDREN ALSO RECEIVE PRE-SCHOOL EDUCATION AND AFTER SCHOOL/HOMEWORK ASSISTANCE, SCHOOL SUPPLIES, SNACKS AND RECREATION ACTIVITIES.

FOOD: THE MANNA HOUSE FOOD PROGRAM, A HOT MEAL PROGRAM PROVIDES BREAKFAST, LUNCH, AND DINNER SEVEN DAYS PER WEEK TO THOSE IN NEED. THE SHELTER ALSO PROVIDES A FOOD PANTRY, WHERE BOXED FOOD IS DISTRIBUTED DAILY TO THE IMPOVERSHED. LAST YEAR A TOTAL OF 109,605 HOT MEALS WERE SERVED OR AN AVERAGE OF 300 MEALS A DAY. IN ADDITION THE SHELTER PANTRY PROVIDED 249,245 MEALS TO INDIVIDUALS LIVING IN PVERTY OR 683 MEALS A DAY.
