SHELTER: ODS OPERATES AN EMERGENCY SHELTER FOR 14 SINGLE WOMEN, 42 SINGLE MEN - PLUS 14 OVERFLOW BEDS, AND 29 MEMBERS OF FAMILIES INCLUDING 20 CHILDREN. THE SHELTER CASE MANAGEMENT SERVICES TEAM PROVIDES COMPREHENSIVE SERVICES INCLUDING COUNSELING, CRISIS INTERVENTION, GOAL PLANNING, REFERRALS TO ADDITIONAL COMMUNITY SUPPORT SERVICES, FINANCIAL MANAGEMENT, JOB SEARCH AND SKILL TRAINING, TRANSITION TO HOUSING SUPPORT AND ACCESS TO HOT MEALS, SHELTER, SHOWER, TOILETRIES, CLOTHING LAUNDRY FACILITIES AND COMPUTERS/PHONES. CHILDREN ALSO RECEIVE PRE-SCHOOL EDUCATION AND AFTER SCHOOL/HOMEWORK ASSISTANCE, SCHOOL SUPPLIES, SNACKS AND RECREATION ACTIVITIES.

FOOD: THE MANNA HOUSE FOOD PROGRAM, A HOT MEAL PROGRAM PROVIDES BREAKFAST, LUNCH, AND DINNER SEVEN DAYS PER WEEK TO THOSE IN NEED. THE SHELTER ALSO PROVIDES A FOOD PANTRY, WHERE BOXED FOOD IS DISTRIBUTED DAILY TO THE IMPOVERSHED. LAST YEAR A TOTAL OF 109,635 HOT MEALS WERE SERVED OR AN AVERAGE OF 300 MEALS A DAY. IN ADDITION THE SHELTER PANTRY PROVIDED 250,757 MEALS TO INDIVIDUALS LIVING IN POVERTY OR 687 MEALS A DAY.

HOUSING: ODS USES HOUSING FIRST, AN EVIDENCE BASED MODEL WHICH SEEKS TO CONNECT THE HOMELESS TO HOUSING AS QUICKLY AS POSSIBLE, WHILE PROVIDING THE SUPPORTIVE SERVICES PEOPLE NEED TO AVOID RETURNING TO HOMELESSNESS. ODS OPERATES 47 UNITS OF SUPPORTIVE HOUSING IN 7 PROPERTIES AND DELIVERS CASE MANAGEMENT AND FIDUCIARY SERVICES TO MORE THAN 44 FORMERLY HOMELESS INDIVIDUALS AND FAMILIES.
